REPORT OF THE TRUSTEES

NVCA was founded to be the successor to Newchurch Village Community Association which donated all of its funds to NVCA on the 1st July 2021.

Legal Status

NVCA was incorporated on the 3rd June 2019 and became a registered charity on the 22nd April 2021. NVCA is also known as Newchurch Village Community Association.

Aims and Purposes of NVCA

- 1. To provide or assist in the provision of facilities in the village of Newchurch-In-Rossendale and the surrounding area, in the interests of social welfare for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disability, financial hardship or social circumstances with the object of improving their conditions of life.
- 2. To provide or assist in the provision of public amenities within the village of Newchurch-In-Rossendale and the surrounding area.
- 3. Acts for the public benefit taking a balanced view to protect and enhance the character and amenities of Newchurch-in-Rossendale and the surrounding area including:- high standards of planning/architecture, educate in the geography, history, natural history and architecture of the area of benefit, preservation, protection development and improvement of features of historic or public interest; and to support such general charitable purposes according to the laws of England and Wales as the trustees may in their absolute discretion determine, through the provision of grants to registered charities.

Financial review

NVCA generated operating income of £6,283 in the year.

The main expenditure was fundraising costs of £1,608 and administrative costs of £2.642.

The net operating outturn for the year was a surplus of £2,089 of which £1,434 are restricted funds and £88 allocated as designated funds, leaving £567 as the net surplus for the year.

The unrestricted funds to be carried forward to 2023-24 are £6,495 of which £1,500 are designated unrestricted funds.

Chair's Statement

I took over from Danny Allen as Chair in February 2023, and would firstly like to personally thank him for his amazing support over the last 7 months.

To touch on briefly events that took place from October 2022 until February 2023 –. Once again, we held the Bird of Prey at the School which was quite successful thanks to Grant Funding. The Christmas Fair which was held for the first time at St Nicholas School was unfortunately not that well attended. The Walking Nativity in December was again successful. The Kings Coronation Tea Party held in May of which we were successful in obtaining Grant Funding.

In April we had meetings with Rossendale Borough Council looking into NVCA taking over the little hut on Woodside Crescent for community use and also to try to take some events and activities onto the estate instead of it all being up at the top of Newchurch. After initial inspection of the premises, the council agreed to look at some of the repairs and legal inspections necessary for us to be able to become tenants of the property. As to date and after much chasing, we are still no further on with this project.

We have secured a couple of other grants this year which have helped us to enhance our area: Firstly, we secured a grant from The Duchy of Lancaster for £900 to establish flower beds on the green on Church Street. Out of the grant money, we hired a rotavator, bought plants, compost, topsoil and have also purchased a hedge trimmer to use for any communal space which is not looked after by anyone. Work began on the beds in early July with great community spirit. Thank you to everyone who has given their time, this will be an ongoing project. Secondly, we secured a grant for £600 from Lancashire County Council to purchase a new bench for the Little Park. This has now been installed at the bottom end of the park.

NVCA again received a quantity of bulbs from the council and also a number of plants for us to use in the Little Park and also the new flower beds. Thanks to volunteers who have worked hard planting all these and regularly giving their time to keep the park looking wonderful. A new larger Village Library has been built and installed and our grateful thanks go to Brian for doing this, it is very well used. Danny and his team have once again cleared the Bolton Woods paths and other maintenance projects in the area which keep our environment safe. The large Pothole outside the Shops on Top Barn Lane have now been repaired to make it safer after negotiations with the shop owner.

NVCA continues to support the maintenance of the defibrillators at the Little Park and the Staghills Play Area. Thanks to Dawn Taylor and Simone Cudworth for their continuous persistence in getting the Staghills defibrillator connected for such an apparently small thing to happen it was like moving a mountain.

NVCA continues to support the local food bank project and several members monitor the food box at the bus stop at the top of Church Lane thank you to all of them.

In June a few members attended the Pride of Rossendale Awards to support Danny as he was nominated Man of the Year. Unfortunately, on this occasion he did not win but there's always next year. I would like to take this opportunity to thank everyone who has supported NVCA over the past year. To all those who have given their time and talents to help to organise events and to help to enhance and maintain Newchurch.
